# **Outreach Proposal**

#### **Treasurer's Report**

(see attached) \$6,800.00 deficit for the month of October. Pledges are \$21,000.00 less than budgeted. Money was saved in operational expenses to levy only a \$14,000.00 YTD loss.

### **Worship Times**

Due to conflicts with the timing of getting choir members singing in the 8:30 service rehearsed with the additional choir members of the 10:00 service and insufficient time for 8:30 acolytes to attend church school services between the two services. Steve suggested moving services to 10:30am and some vestry members suggested trying the 10:30 service from January 2014 through June 2014 and reassess the situation at that time. This change will be announced to the parish immediately.

### Pledge Cards/Budgeting

The pledge cards collected on Stewardship Sunday were help in a sealed enveloped in the parish safe and not opened in order for the vestry to consider the announced plan to follow a "Faith Based Pledging" in which cards were collected, not reviewed and burned in honor of the process. Vestry decided that they would uphold the promise of the commitment to the Faith Based Budgeting process. Cards will ceremonially be burned during an upcoming service.

### **Nominating Committee**

Kathy Golden was selected by the vestry to replace Geoff Gregory on the nominating committee due to Geoff's resignation. A Nominating Committee Meeting was called for the next Monday evening. A vestry member asked if the Priest-in-Charge had released his names for his chosen Executive Committee. Priest-in-Charge stated he had not made his selections yet.

#### **Next Steps in the Healing Process**

Consensus Building – Discussion was held to consider whether the Vestry should move to the Consensus Method of Voting. Under this method a vote can be taken in which vestry member could vote "Thumbs Up" in which they are in support of the motion, "Thumbs Neutral" (sideways) in which they were not in support of the motion but could be supportive of the decision to move forward and "Thumbs Down" in which the vestry member needed more time to consider the motion and talk thought support or alternative. Motions voted unanimously in any combination of the "Up" or "Neutral" position would pass and any particular "Down" vote would allow the vestry to select either more time to discuss the motion or to table the motion for possible future reconsideration. Some vestry members thought this would bring people into discussion and not allow anyone to feel isolated from the discussion. This would be a positive way to build common ground, demonstrate united leadership and a movement towards healing.

**Motion:** To hold all future Vestry Votes between this particular vote and at which time the new Rector is called and presented to the Parish in the aforementioned *Consensus Style*. (Naegel/Greene) Consensus Achieved

#### **Executive Committee Changes:**

- 3. Vestry will assign responsibilities recently focused on or considered by the executive committee to "special committees' made up of interested vestry members at large.
